- Nominee must have been an adult (18 years of age) resident of North Olmsted for at least five (5) years and be a current North Olmsted resident.
- Nominee must have made a contribution to the betterment of North Olmsted in at least two (2) of the following areas: church, school, civic, or recreation.
- The nominee must not have received monetary reimbursement for contributions cited.
- Current President and Vice-President of the Executive Board of Community Council are not eligible for consideration during their term of office. All other Board Members are eligible.
- 5. Since Community Council is a non-political organization and should attempt to avoid the appearance of endorsing a candidate, candidates for political office, the elected members of City Administration and members of City Council are not eligible for consideration during their term of office.

To nominate a candidate for Citizen of the Year, first read the eligibility requirements. If your nominee meets all the requirements, complete the questionnaire at the bottom of this page. Then, in as much detail as possible, complete the CITIZEN OF THE YEAR RESUME on the back, listing the information requested. Keep in mind that the nominee must have contributed in at least two (2) of the four (4) areas listed. If additional space is required, you may attach only one additional sheet.

IMPORTANT - the Selection Committee will judge your nominee solely on the information you provide. Selection will not be made on the personal knowledge of the Selection Committee, but only on what is contained in your application. It is not the number of nominations submitted but the completeness of the application that is important.
